ABSTRACT  
The Bulgaria: Post-Distribution Monitoring of Cash-Based Interventions - 2025 dataset evaluates the impact of UNHCR’s cash-based interventions (CBI) in Bulgaria. Between October and December 2024, 4,225 households (9,158 individuals) received multi-purpose cash assistance (MPCA), winterization support, and education grants. Additionally, the Bulgarian Red Cross (BRC) provided cash-for-education assistance to 194 individuals. A post-distribution monitoring (PDM) survey was conducted via telephone interviews from January 16-28, 2025, with 431 randomly selected households, ensuring a 95% confidence level and a 5% margin of error. Of these, 40 were BRC beneficiaries, while 391 received support directly from UNHCR. The dataset captures household spending, financial coping strategies, and program effectiveness.

## Sampling

## SAMPLING PROCEDURE

The sample was selected using a probability-based simple random sampling method, targeting households registered under Temporary or International Protection in Bulgaria. This ensured an unbiased representation across various demographics and geographic locations. A total of 258 households participated in the survey. Sampling was aligned with the program's operational coverage to accurately capture feedback from cash assistance recipients. Measures were implemented to address non-response bias, and replacement households were identified when necessary to maintain the target sample size.
