ABSTRACT

The UNHCR Results Monitoring Survey (RMS) is a household-level survey covering people who are directly or indirectly assisted by UNHCR, including refugees and asylum seekers, internally displaced persons, returnees, stateless and others of concern. Additionally, in the Republic of Korea the survey covered rejected Asylum-Seekers. The objective of the survey is to monitor impact and outcome level indicators on education, healthcare, livelihoods, protection concerns, shelter, and water and sanitation. The results contribute to an evidence base for reporting against UNHCR's multi-year strategies to key stakeholders.

The RMS can be implemented in any operational context. A standard structured questionnaire has been developed for the RMS, which can be conducted as a stand-alone survey or flexibly integrated with other data collection exercises. The data includes indicators collected at both the household and individual (household-member) level, and results are statistically representative.
